Notice to Vintage Place Residents

Below is a summary of the key elements of the parking policy, which will be enforced at all times:

- 1. Residents can park in any Reserved or Guest spaces throughout the Vintage Place Community with a valid VP parking sticker displayed.
- 2. Guests can only park in Guest spaces unless a resident provides them with a VP hangtag, in which case they may park in any Reserved spaces.
- 3. All Residents must register their vehicles with Sequoia Management and properly display a Vintage Place parking sticker on the rear window of their vehicle [or windshield/ handlebars for motorcycles].
- 4. Improperly parked vehicles, i.e., not in compliance with the parking policy, may be towed immediately.
- 5. Current residents can register up to two (2) vehicles per lot by submitting the attached form (which must be completed in its entirety). Residents who require more than two (2) parking stickers must request them in writing to the Board of Directors through the Management Agent. All future residents must register their vehicles as soon as possible after becoming a resident. As indicated on the attached form, a parking sticker will be issued upon submission of a complete parking registration form to the Management Agent. The parking sticker must be affixed to the vehicle in the manner prescribed below. One (1) "Resident Guest" hang tag per lot will also be issued.

Because of the limited number of spaces in the community, all residents are encouraged to be courteous and to try not to park directly in front of other resident's homes with the understanding that there are NO assigned spaces. Garage townhouse owners are encouraged to utilize their garage and driveway space whenever possible; and, if not possible, to park in a Guest or overflow parking area.
